

HON'BLE DR. JUSTICE D Y CHANDRACHUD

Hon'ble Dr Justice Dhananjaya Y Chandrachud is a judge of the Supreme Court of India. He was previously the Chief Justice of the Allahabad High Court (October 2013 – May 2016) and a judge of the Bombay High Court (March 2000 – October 2013). He joined the Bombay Bar after obtaining an LLM and SJD from Harvard Law School. Justice Chandrachud graduated with a BA (Honours) in Economics from St Stephens's College, Delhi. He completed his LL. B from Delhi University.

During his career as a lawyer, he was visiting Professor of Comparative Constitutional Law at the University of Mumbai and taught International Law at the University of Oklahoma. He was designated as a Senior Advocate (1998) and was Additional Solicitor General for India (1998–2000).

He has been a guest lecturer at Harvard Law School, Yale Law School, Australian National University, University of Witwatersrand, South Africa and the University of Hawai'i. He has been invited by several organizations as a speaker, including the United Nations High Commission on Human Rights, International Labour Organisation, United Nations Environmental Program, the World Bank, Asian Development Bank and the Association of Asian Constitutional Courts.

Since his appointment to the Supreme Court in 2016, Justice Chandrachud has delivered several seminal judgements, including on decriminalization of homosexuality; decriminalization of adultery; declaration of privacy as a fundamental right; caste and gender discrimination; protecting the rights of the disabled; environmental jurisprudence; and insolvency and bankruptcy.

As the Chairperson of the e-Committee of the Supreme Court of India, he is spearheading a digital transition of the judicial system in India, with an aim of ensuring access to all litigants. During his tenure, the e-Committee, inter alia, developed the:

- (i)National Judicial Data Grid to track pendency of cases;
- (ii)Virtual courts to deal with traffic violations through online adjudication;
- (iii)E-Filing software for digital filing of cases;
- (iv)Inter-Operable Criminal Justice System for live electronic exchange of data between the police and judiciary;
- (v) Portal for electronic payment of fines, fees, and deposits; and,
- (vi) Judgement search portal with a free text search engine.

Under his guidance, the e-Committee has also taken steps to ensure that digital services are accessible to marginalized sections. e-Sewa Kendras have been created in court complexes to provide digital aid to people who do not have access to the internet or electronic equipment. Measures have been taken to make websites accessible to persons Justice Chandrachud also constituted a subdisabilities. committee to specifically look into the issues faced by women, the LGBTQIA+ community, and persons with disabilities in accessing digital services. The e-Committee is currently undertaking projects relating to digitisation of court records, live streaming of court hearings, and enhancing the security and privacy of data of users accessing e-Courts services. During the Covid-19 pandemic, the e-Committee ensured that courts across the country - the District judiciary, High Courts, and Supreme Court – continued to hear cases through video conferencing platforms.



HON'BLE MS. ATHITA KOMINDR

Ms. Athita has twenty years of experience in the fields of international trade and economic law, arbitration, multilateral dispute resolution, and the rule of law and development. Prior to joining the United Nations, Ms. Athita mainly advised and worked with numerous Thai agencies, including the Thailand Institute of Justice, the Thai Ministry of Science and Technology, and the Thailand Arbitration Center where she managed the Arbitration and Legal Affairs Divisions. She also worked for the Thai Ministry of Commerce in Bangkok (2002–2005) and Geneva (2005–2010), representing Thailand in bilateral, regional, and multilateral trade negotiations, WTO dispute settlement, and treaty drafting.

Hon'ble Athita Komindr is Head of the UNCITRAL Regional Centre for Asia and the Pacific (UNCITRAL RCAP), managing technical assistance and capacity building programming available to over 50 States in Asia and the Pacific in key areas of commercial law, including dispute resolution, MSMEs, international contract practices, sale of goods, electronic commerce, transport, insolvency, international payments, secured transactions, and procurement. In that capacity, she coordinates with Governments and international and regional organizations with respect to trade law reform activities aimed at achieving Sustainable Development Goals.

Admitted to the New York Bar, Ms. Athita has experience in both common and civil law traditions in the public and private sectors and holds degrees from Harvard College, Georgetown University Law Center, and Harvard Law School.




HON'BLE MR. JUSTICE S R BANNURMATH

Hon'ble Mr. Justice S. R. Bannurmath is a Science and Law graduate, and in 1979 he started independent practice in Belgaum dealing in various branches of law. After moving to Bangalore, he predominantly practiced in Criminal and Constitutional cases in Karnataka High Court and appeared regularly in India's Supreme Court. In 1990, he was appointed as an Additional State Public Prosecutor, and in 1994 he was appointed as State Public Prosecutor. In June 1997, he was elevated as a Judge of the High Court of Karnataka. Justice Bannurmath has rendered hundreds of landmark judgments in all branches of law, including the Haseena case also known as the acid victim case. He not only sentenced the accused to imprisonment for life but also ordered the accused to pay monetary compensation to the victim, a first of it kind order in the country, and directed the Govt. to implement a scheme framed by him for such acid victims, including medical and monitory help, rehabilitation, etc.

The Supreme Court designated him to Monitor the Mental health of citizens of Karnataka. He was the founder President of Bangalore Mediation Centre (BMC) and contributed to its growth and fame. As the. Under his leadership as the Chairman of Court Computerisation Committee, Karnataka High Court was the first High Court in India to develop its Operating System to manage entire court procedure like filing, scrutiny, certified copies etc. He was elevated as Chief Justice of Kerala in 2009 and retired on 22.01.2010. He was the Chairman of, Maharashtra State Human Rights Commission from September 2013 till January 2018. He is presently the Chairman of the Karnataka State Law Commission.

A regular guest resource person to the National Law School Universities at Bangalore and Mumbai and various law institutions in the country, Justice Bannurmath is also the patron of CARE INDIA MEDICAL SOCIETY Pune, a palliative cancer care Centre Pune He is an Honorary Vice-Chairman of Bangalore International Mediation and Conciliation Centre (BIMACC).



HON'BLE MR. JUSTICE CYRIAC JOSEPH

Hon'ble Mr. Justice Cyriac Joseph is the Honorary Chairman of BIMACC. He is presently the Lok Ayukta (Ombudsman) of the State of Kerala. A law graduate from Government Law College, Trivandrum, was admitted to the Bar in 1968 and practised in Kottayam and Kerala High Court. He held the office of Additional Advocate General, and on 6th July 1994, he was appointed as Judge of Kerala High Court. On 7th July 2008, he got elevated as a judge of the Supreme Court. Before that, he was a judge of Delhi High Court, Chief Justice of Uttarakhand High Court and Chief Justice of Karnataka High Court.

During his tenure as the Chief Justice of Karnataka, he spearheaded the establishment of the famous Bangalore Mediation Centre, India's largest court-annexed mediation centre at that time. Post-retirement, he was a member of the National Human Rights Commission and also officiated as a Chairman.



MS. FABIENEE VAN DER VIEUGEL

MODERATOR - SESSION 1

Ms. Fabienne van der Vleugel is Belgian and French national. She is a lawyer specializing in the transfer and restructuring of enterprises and is practising law since 1995. A former member of the Brussels Bar and presently a member of New York Bar and Meaux Bar (East Paris). She studied law in Belgium (Namur, magna cum laude); Bachelor of Laws (Louvain la Neuve, magna cum laude); in Spain (Seville, Erasmus, magna cum laude); LL.M from Georgetown University Law Center, Washington DC. She is the managing founding partner of her law firm VDV AVOCATS (France, Serris) and Associate Professor at the University Gustave Eiffel-Meaux in business law. She is a trained CMAP and accredited mediator CAP'M®, IEAM, AMIDIF, CMCC, MCIArb, bMediation and Belgian Federal Commission.

Hon'ble Justice P. S. Dinesh Kumar was a National Merit Scholar Certificate in High School. After graduating in law, he was admitted to the Bar in the year 1990 and worked in the chambers of Mr. Justice Shivaraj V. Patil, former judge, Supreme Court of India. In the year 1998, he functioned as an Additional Central Government Standing Counsel in the year 19983. In 2003 he became a Senior Standing Counsel for the Government of India. He has served as a Senior Panel Counsel for the Central Bureau of Investigation (CBI), Union Public Service Commission, University Grants Commission, All India Council for Technical Education, National Council for Teacher Education and several other organisations. MR. NIRANJAN J BHATT MODERATOR- SESSION 3

Mr. Niranjan Bhatt is an octogenarian lawyer practicing on the civil side in the Gujarat High Court and subordinate courts for the last 64 years. He is highly respected in the legal circle and has several reported judgments to his credit. He was a member of the Indo-US Study Group for the reforms in the civil justice system.

Mr. Bhatt is one of the pioneers of Mediation in India. In 2001 he attended an Advance Mediation study at the Harvard Law School. Mr. Bhatt was a member of a delegation that visited San Francisco, USA, in 1996 to study and observe Alternative Disputes Resolution processes in the USA. He attended the Rule of Law World Conference at Berkeley University, California, USA, in 1997 and his paper on "Case Management – A modern Concept" was presented at the conference. He was the Convener of Ahmedabad Mediation Centre.

The Supreme Court of India appointed him as a co-mediator for border disputes between Assam and Nagaland. He was assigned to conduct a mediation awareness programme and sensitization of Judges for making mediation references in Gujarat by Gujarat Legal Services Authority. After moving to Bangalore, he predominantly practiced in Criminal and Constitutional cases in Karnataka High Court and appeared regularly in India's Supreme Court. In 1990, he was appointed as an Additional State Public Prosecutor, and in 1994 he was appointed as State Public Prosecutor. In June 1997, he was elevated as a Judge of the High Court of Karnataka. Justice Bannurmath has rendered hundreds of landmark judgments in all branches of law, including the Haseena case also known as the acid victim case. He not only sentenced the accused to imprisonment for life but also ordered the accused to pay monetary compensation to the victim, a first of it kind order in the country, and directed the Govt. to implement a scheme framed by him for such acid victims, including medical and monitory help, rehabilitation, etc.

The Supreme Court designated him to Monitor the Mental health of citizens of Karnataka. He was the founder President of Bangalore Mediation Centre (BMC) and contributed to its growth and fame. As the. Under his leadership as the Chairman of Court Computerisation Committee, Karnataka High Court was the first High Court in India to develop its Operating System to manage entire court procedure like filing, scrutiny, certified copies etc. He was elevated as Chief Justice of Kerala in 2009 and retired on 22.01.2010. He was the Chairman of, Maharashtra State Human Rights Commission from September 2013 till January 2018. He is presently the Chairman of the Karnataka State Law Commission.

A regular guest resource person to the National Law School Universities at Bangalore and Mumbai and various law institutions in the country, Justice Bannurmath is also the patron of CARE INDIA MEDICAL SOCIETY Pune, a palliative cancer care Centre Pune He is an Honorary Vice-Chairman of Bangalore International Mediation and Conciliation Centre (BIMACC).
